
Little Cedar Lake

- Size: 260 acres
- Max. Depth: 56 feet
- Little Cedar Lake in within the Milwaukee River watershed
- Cedar Creek feeds in at the Northwest Corner from big Cedar Lake
- Cedar Creek feeds out at the South End
- Public Access: boat launch, fishing pier, public beach thru Ackerman's Park
- Fish: Panfish, Largemouth Bass, Northern Pike and Walleye

 - All Volunteer-No Employees

- Local Boating Regulations
- Lake Patrol (By Big Cedar Lake Patrol)
- Weed Control (Permitted by WI DNR)
 - 5 Year Aquatic Plant Management Plan
 - Mechanical for all weeds (by Big Cedar Lake Personnel)
 - Chemical for Eurasian Milfoil only, if necessary
- Other Aquatic Invasive Species Purple Loosestrife in Cooperation with Wash Co. AIS coordinator
- Algae/Bacteria (E. coli testing) as required
- Water Clarity Testing

 - Annual Budget approved at Annual Meeting
 - Tax Mil Rate included in Property Taxes
- Other Invasive Species
 - Zebra Mussels, Starry Stonewort via Clean Boats/Clean Waters

- Maintain Website
